REQUEST FOR AN ACADEMIC or STUDENT LICENSE



IMPORTANT - READ CAREFULLY BEFORE SIGNING:

- The Licensee shall use the licensed software only academic or student purposes. She/he shall
 only use the software for research and education without prior written approval by Ucamco.
 She/he shall not use the Software for commercial gain, including subcontracting part of or
 performing commercial PCB production. If she/he does not abide by these restrictions,

- 2. The Licensee shall not disclose information about the licensed software to Ucamco competitors, directly or indirectly, and shall not detract to the good name of the Software to any party. This clause remains valid for five (5) years after expiration or termination of this agreement.
- 3. Ucamco is under no obligation to provide support on the software or to provide software updates.
- 4. The license normally expires at the end date specified above. However, Ucamco can unilaterally terminate the agreement, with immediate effect. The Licensee waives all rights to compensation arising from the expiration, termination or failure to renew the license.
- 5. This agreement does not create any agency or partnership relationship between the parties. The Licensee acknowledges and agrees that he is not entitled to receive any commission, discount or any other compensation from Ucamco relating to the use of the license.
- 6. No other license on any patent, copyright, trademark or trade secret or any intellectual property is granted or implied by Ucamco under this agreement.
- 7. Licensee waives all right for compensation arising from the license and the use of the licensed software.
- 8. This license is subject to the Software License Agreement that comes with the licensed software. The clauses in this request have precedence over the Software License Agreement.
- 9. The Licensee hereby warrants that
 - a. he will delete all copies of the licensed software and return all documentation and other materials provided under this agreement at the latest one week after expiration of the license;
 - b. will use Ucamco software strictly in accordance with the attached license agreement;
 - c. has not used and will not use unlicensed ("cracked") Ucamco software, has not bypassed nor will bypass the license protection in any way.
- 10. Ucamco provides the license based on these warranties. The Licensee therefore authorizes Ucamco representatives to verify compliance with the warranties above on its premises from the date of signature till three years after termination of the license.
